



General Safety Program Fact Sheet

Functional Role

The General Safety Program is responsible for ensuring regulatory compliance, establishing safe work practices, and providing training and safety consultation services to faculty, staff and students operating in high-risk environments. This work unit also maintains campus responsibility for Shop Safety, Fall Protection, Lockout/Tag-out, Specialized Equipment Operator Certification, CPR/First-Aid/A.E.D. certifications, Theater & Performing Arts Safety and other Cal/OSHA mandated programs.

Performance Objectives

- Ensure regulatory compliance through biannual inspections, audits and training in OSHA Top Ten areas including: Fall Protection/Ladder Safety, Energy Isolation/ Lockout-Tagout, Specialized Equipment Operations, and Scaffolding
- Continuously update campus AED Written Program as needed. Maintain triannual inspection schedule and required program documentation. Serve as consultant for campus departments purchasing new AED units.
- Expand campus Shop Safety Program resources available to shop managers/supervisors and users to include: on-line training courses, machine hazard analysis documents, and best practices. Increased focus on chemical storage, labeling, and chemical waste disposal during biannual inspections
- Support continuous growth of campus Theater & Performing Arts safety program initiatives. Review safety plans/documents, perform inspections, and provide training and consultative services as requested.

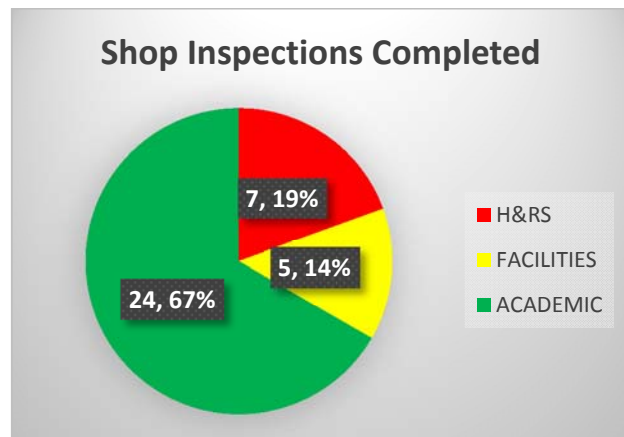
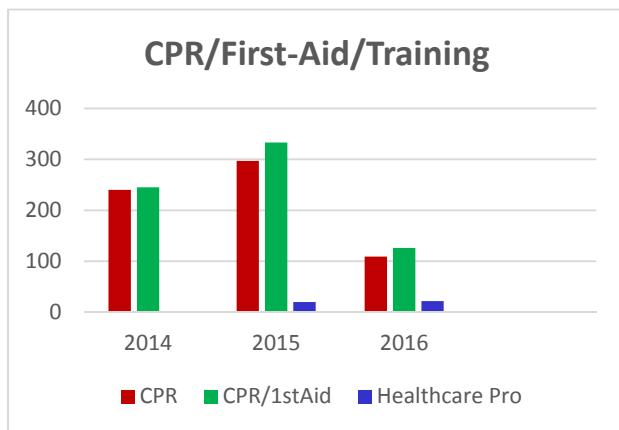
