For non-ARCOS reporters: A copy of the completed form must be submitted to the DEA either by mail or email at the close of the month product was shipped

Refer to the instructions on the reverse side of the DEA Form 222 for additional information on how to complete the Form.

- All shipments of CII products **must** be preceded by the issuance of a DEA Form 222.
- Send only the product that is listed on the Form.
- Send all of the product on the Form in one box; do not ship multiple boxes.
- CIII-V products should not be co-mingled with CII products.
- Include a packing slip with the box; write the DEA Form 222 number on the first page of the packing slip.
- Ship the box as soon as is practicable, but no later than 45 days after the Form was dated by the signatory.
